Order

In terms of Section 14(1) of the NCTE Act, 1993 Baharagora College, Baharagora, East Singhbhum, Jharkhand - 832 101 had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting B.Ed. Course of one year duration from the academic session 2004-2005 with an annual intake of 100 (one hundred) students.

- On scrutiny of the application submitted by the institution, the documents attached therewith, the inputs received from the visiting team, the Committee has noted the following:
 - The institution has acquired the land for setting up the teacher education institution.
 - At present the institution will function from the two of the existing buildings of the ii.
 - The institution has created an Endowment Fund of Rs.5.00 lakhs but Reserve Fund equivalent to three months salary of the teaching staff has not been 111
 - The institution has selected the Principal and 07 (seven) teachers for the said course and the list of faculty members has also been approved by the affiliating iv. University i.e. Registrar, Ranchi University, Ranchi.
- Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants recognition to Baharagora College, Baharagora, East Singhbhum, Jharkhand- 832 101 for B.Ed. Course of one year duration from the academic session 2005-2006 with an annual intake of 100 (one hundred) students subject to fulfillment of the following:
 - a) The institution will ensure that Principal and at least 07 (seven) faculty members duly approved by the affiliating University are in position for an intake of 100 students before the commencement of the course and a report to this effect shall be sent to the Eastern Regional
 - b) The institution shall submit the documentary evidence with regard to separate Deptt/ autonomy for B.Ed. Department, library, educational, psychology, and science laboratories, separate building for B.Ed. course, salary to the teaching and non-teaching staff as per State
 - Government / UGC scale as required under NCTE norms, and appointment of teachers on full time, and regular basis and shall intimate action taken in this regard to ERC, NCTE before commencement of the academic session.
 - c) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Eastern Regional Committee.
 - d) The institution shall shift to its own premises within three years from the date of recognition
 - e) The institution will'create reserve fund for an amount equal to three months salary of the teaching staff and a confirmation to this effect be sent to this office.
 - f) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations.

- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, the State Government etc.
- The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
- If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.

ORDER

WHEREAS, The Baharagora College, Baharagora, East Singhbhum, Jharkhand-832101 (Code No.APE00377) was granted recognition by ERC, NCTE on 24.04.2005 for conducting B.Ed. Course of one year duration with an annual intake of 100 from the academic session 2005-2006 subject to fulfillment of some conditions mentioned therein.

- 2. AND WHEREAS a Public Interest Litigation vide W.P.(PIL) No.327 of 2011 filed by Shiv Shankar Munda -Vs- Chairperson NCTE & Ors in the Hon'ble High Court of Jharkhand at Ranchi. As per direction of the Hon'ble High Court of Jharkhand, the said institution was inspected by the NCTE Hars., New Delhi under section 13 of the NCTE Act 1993. Accordingly, the NCTE Hars. issued a deficiency letter to the institution along with the report of the Prof. Arora Committee for greater clarity of the deficiencies vide No.93-102/2014/NCTE/Insp./A87033 dated 21.04.2014 on reasons mentioned therein.
- 3. AND WHEREAS after considering the matter in various meetings, the ERC in its 175th meeting held on 09.09.2014 considered the facts on records available in the file, the inspection report of the NCTE Hars, as well as reply submitted by the institution dated 26.08.2014 in response to ERC's show cause notice U/S 17(1) dated 13.08.2014 and as decided by ERC, withdrawn order was issued to the institution vide No.27385 dated 24.09.2014 from the academic session 2015-2016 in terms of Section 17(1) of NCTE Act 1993 on the following grounds.
 - (i) The institution is not having infrastructure and instructional facilities as per the NCTE norms. The institution was to shift to its own premises within three years from the date of recognition i.e. by 19.05.2008. But even after more than 8 years, it is continuing at the same place. The institution has not submitted any application for shifting of premises along with other required documents.
 - (ii) The institution does not fulfill the prescribed norms regarding engagement of teaching and supporting staff and also in respect of service conditions of staff. The institution has not appointed teaching faculty on regular basis as per NCTE norms.
- 4. AND WHEREAS the institution preferred an appeal to the NCTE Hars, against the ERC's order dated 24.09.2014. The Appellate Authority vides order No.89-23/2015-Appeal/2nd Meeting-2015/3781 dt.05.05.2015 remanded back the case to ERC with a direction grant 3 months time to fulfill the norms and standards as per NCTE Regulations, 2014. Committee decided to grant three months time to the appellant institution for fulfilling the norms & standards and comply with the NCTE Regulations, 2014.
- 5. AND WHEREAS the ERC in its 188th meeting held on 19-20 May 2015 considered the appeal order dated 05.05.2015 along with original file of the institution and as decided by the ERC, a letter was issued to the institution dated 05.06.2015.

6. AND WHEREAS the ERC in its 191st meeting held on 14-15 July 2015 considered the letter dated 26.05.2015 received from the Director of Higher Education, Government of Jharkhand-committed that all such requirements along with appointment of full time faculty will be complied with as per new Regulation 2014 by 31.10.2015, wherein the ERC has decided as under:

(i) Recognition of the institution be continued.

(ii) Review the status will be taken up after 31st Oct.2015. Deficiency found if any, will be communicated to the institution, concerned University and State Government for compliance.

iii) If the institution fails to comply the deficiencies, further course of action shall be

taken as per norms.

7. NOW THEREFORE, the recognition of the institution viz. Baharagora College, Baharagora East Singhbhum, Jharkhand-832101 (B.Ed.) (Ranchi University) (Code No.APE00377) for B.Ed. Course is allowed to continue.
